C. Automatically Collected Information

When you browse our website, we may collect non-personally identifiable data through cookies and analytics tools, including:

- Browser type and version
- Pages visited and time spent on the site
- Referring websites and links clicked
- Cookie data and tracking pixels

3. How We Use Your Information

We use the information we collect for the following purposes:

- To respond to your inquiries or contact requests
- To schedule and manage self-guided tours
- To personalize your experience and improve our website functionality
- To provide relevant property updates and marketing communications
- To perform website traffic analysis and enhance site performance
- To serve targeted ads through digital marketing platforms (e.g., Google Ads, Facebook)
- To maintain security and prevent fraudulent activity

We do not sell or rent your personal information to unrelated third parties. We may share your data with trusted service providers who assist with our website, marketing campaigns, analytics, or tour logistics. All such partners are contractually obligated to maintain confidentiality and use the data only for specified services.

4. Cookies and Tracking Technologies
